## Proposed Agreements

Once committed, you will be asked to sign a more comprehensive legal Agreement. The following are the Proposed Agreements for YOUR INFORMATION ONLY at this time:

1. I agree to manage my business/organization in accordance with the principles and teachings taught in Money & You and all other Excelerated Programs.
2. I agree to build my personal wealth. I will maintain a tithing, savings and investment account, and add to them on a regular basis.
3. I agree to undertake the necessary steps and curriculum that constitute this Program.
4. I agree not to teach or use any of the games, exercises or course materials utilized by Excelerated without written permission.
5. I agree NOT to go into competition with Excelerated Business Schools/Money and You Program and present the Money & You or its major games at any time. If I wish to be a licensed Promoter, I will go through the process of becoming an Excelerated Promoter and sign all the proper Distribution Agreements and Policies. If I want to teach programs, I will create my own games, curriculum, and be creative on my own right so that I earn the respect and admiration of those in the seminar field. I will acknowledge the source of any Excelerated systems.
6. I acknowledge that I will learn many tools – and have the capacity – to create my own games, exercises and course materials without having to copy or use other people's/organizations' materials, especially without their written consent.
7. I agree not to use my position as an Instructor/Program Director to coerce or influence any Participants, Logistics Team Members or Guest of programs in non-program related issues.
8. I agree not to have a sexual or intimate relationship with any Instructor Candidate, Participant, Logistics Team Member or Guest I meet for the

first time at any Excellerated event for at least 30 days after the event and no integrity issues are in the way of that relationship.

9. I will not use substances classified as illegal by the laws of the area in which I am residing or teaching.
10. I hold myself as 100% responsible for my learning by practicing and being 100% prepared and ready to lead sessions of the program when assigned and/or for which I volunteered.
11. I agree to speak with good purpose only. I know the damage that speaking with bad purpose can create. I will speak with the knowledge that I can empower or dis-empower with the words I speak.
12. All videos and Instructor/Logistics materials, including all handouts and articles, are the property of Excellerated. I agree not to copy any videos or materials without express written permission.
13. I agree to play to all Excellerated's Rules of the Game (Policies), and observe all the requirements and Policies of the ITP.
14. If I should break any of the above Agreements, I will notify Excellerated in writing as soon as possible, wait appropriate action and make amends, if necessary. If over three major agreements are broken, I understand that I will be asked to leave the ITP Program and that no refund will be owed to me.
15. I acknowledge that I am fully responsible for my own results, gains, advancements and progress in this program. I will not blame anyone or the organization if I don't get what I want out of the program. I agree to go for it 100% in the most responsible, resourceful and honorable manner available to me.
16. I acknowledge that this program may not work for me. In the event I determine it doesn't, I agree to responsibly communicate and complete with Kerry Zurier or Excellerated Instructors in charge of the program so that we can complete in a win-win manner for all concern.
